No.	Documents require for TOURIST VISA	Yes
1	One (1) <b>typed</b> and signed application form with complete and accurate details. *Handwritten application form will not be accepted.	
2	Two (2) photograph of passport size with <b>WHITE BACKGROUND</b> , taken within the past six months.	
3	Original passport and Photocopy of passport *Minimum of <b>6(six) months validity</b> from the date you start from your journey, with a blank visa page to affix the visa sticker. *Pages showing the applicant's photograph, details, date of issue and expiry.	
4	Photocopy of UAE Residence Visa *Every applicants must have U.A.E. valid residence visa, a minimum of <b>6(six) months validity</b> . *GCC citizens submit a copy of their valid Emirates ID.	
5	<b>Original Guarantee or a No objection letter to travelling</b> *Sponsor by company -a No objection letter issue on a proper Company's letterhead in original, duly stamped and with the name of the signatory (Only english version) *Investor/Owner/Partner of the company must provide the letter and a valid copy of trade license. *Sponsor by spouse's visa, Letter from the sponsor, Photocopy of Passport and Residence visa also required. *Sponsor by parent's visa, Letter from the parents, Photocopy of Passport and Residence visa also required. (The Children below 15 years olds must provide a No objection letter with signed from father AND mother) *The sponsor name as mentioned on the UAE Residence visa must match with letter. *Handwritten letters, Electronic letters AND Scanned letters will not be accepted.	
6	<b>Itinerary ticket</b> - Copy of confirmed roundtrip airline reservation *The ticket from the airline must show an outbound trip from Dubai. *Ticket Airline PNR number must be accessible on the airline system. *Agency booking or E-mail bookings with no PNR number will not be accepted.	
7	<b>Copy of confirmed hotel reservation</b> * The hotel reservation must start from the date of arrival into Thailand and covering at least half of the trip with a complete information.  * The name of the person (including family members with children or accompanying person names) applying for visa must appear on the hotel reservation. In case where the accommodation is booked under a different name, A letter by typed and signed from the person whose name appears on the booking must be provided along with a copy of his/her passport. * E-mail correspondence without hotel confirmation will not be accepted. ** In case - staying with friends or relative or family members who have accomodation in Thailand,** <b>Additional documents:-</b> - Invitation letter from the owner of the accommodation mentioning a full address of accommodation with contract number and time period to stay in Thailand. <b>- If the Person you're staying with is a Thai Nationality, the following documents are required</b> * Copy of Thai identity card * Copy of passport * Copy of Thai house registration <b>- If the Person you're staying with is a Foreigner living in Thailand, the following documents are required</b> * Copy of passport * Copy of Thai work permit * Copy of accomodation ownership documents or valid of a rental agreement	
8	<b>For Multiple Entries</b> *Original Stamped Bank Statement Balance of the personal account for previous consecutive 6 months not less than <b>25,000 AED</b> for individual traveller and <b>45,000 AED</b> for family travellers	
9	<b>Nigerian National</b> must present Certificate of Clearance from the National Drug Law Enforcement Agency of Nigeria with Original stamp from the Ministry of Foreign Affairs of Nigeria and the Royal Thai Embassy, Abuja.	
10	Visa Fee: 150 AED Single Entry / 700 AED Multiple Entries	
11	Validity of a Visa: 3 months (single entry) / 6 months (multiple entries)	

**Additional Information:**

- Employment in Thailand is prohibited
- Travelers coming to Thailand with this type of visa will be permitted to stay in Thailand for a period not exceeding 60 days.

**\* Important note\***

- a. All documents **MUST BE IN ENGLISH ONLY**
- b. Online visa appointment is compulsory for **EACH** applicant/passport
- c. All applicants must come to the Consulate in person for visa submission except for children below the age of 15 years.  
But Birth certificate/Marriage Certificate also require in case of submission on behalf of spouse and children
- d. Copies of documents taken through **phone/ tablets/ Ipad and printed out** will not be accepted.
- e. Once the documents are submitted to the consulate, it shall **not be returned** to the applicant
- f. Applicants are required to pay a **visa fee which is non-refundable, whether the visa is approved or not**
- g. **The Consulate-General reserves the rights to request for additional documents from each applicant.**  
**Additional documentation may be requested by the Consulate-General.**
